Course Introduction

Course Overview

More than ever, advanced practice providers are taking a more active role with their patients throughout the cancer care continuum. This expanded role has led to a need to improve clinical practice and develop a better understanding of optimizing care for individuals. Advanced practice providers must stay abreast of treatment advances and their integration into clinical practice as well as the ever changing health care climate.

- Formulate a plan for the evaluation and management of a patient with erythrocytosis.
- Illustrate the benefits of implementing survivorship care plans.
- Summarize the process of starting a survivorship clinic.
- Manage the dying patient from a physical, psychological and spiritual perspective.
- Establish networking relationships with clinical colleagues on contemporary nursing solutions.
