Lavin, founder and chairman emeritus of the Alberto-Culver Company, and his wife Bernice, recently gave a \$500,000 gift to the help fund the addition of a \$5 million electrophysiology lab remodel, which includes leading-edge magnetic imaging equipment for the treatment of arrhythmias (abnormal heart rhythms).

Through his distinguished 50-year career, Mr. Lavin turned Alberto-Culver into a multi-billion dollar company, manufacturing a line of personal care products and household items. Although his success now gives the couple the means to donate to worthy causes, charitable giving has always been their interest, even when money was tight in the early days.

"I was very impressed with the care and the innovative spirit that Dr. Steven Higgins and his team were putting into their work on atrial fibrillation," says Mr. Lavin. "From personal experience, I know how important this can be, and I want to both express my confidence and help to move their work along."

The Lavins spend their summers in Rancho Santa Fe and rely on the quality care they receive at Scripps La Jolla.

"The Scripps Regional Cardiac Arrhythmia Center has developed an international reputation for the treatment of complex arrhythmias," says Steven L. Higgins, M.D., director, Regional Cardiac Arrhythmia Center. "The other nine electrophysiologists and I are delighted with this gift that will allow us to expand our treatment opportunities. The Stereotaxis robotic magnetic navigation system we hope to acquire will be one of the first in southern California. Thanks to Mr. Lavin's generosity and that of others, we will be able to provide state-of-the-art ablation therapy of the utmost safety and effectiveness for our patients."

"I value Scripps' focus on the individual patient, and their innovative and entrepreneurial spirit. Those are the keys to success in building a great company or a great health care provider," says Mr. Lavin. "As technology improves, health opportunities must, and will improve too. It's exciting to be a part of helping that."

#### **Patricia Butler Still Leads By Example**

Patricia Butler was always a leader – and still is. With a long list of accolades and accomplishments in her career, and in philanthropy, she continues to give to help others.

Pat was the only female law student among 40 men in her 1931 graduating class at Emory University of Law, Atlanta. Then, not being able to find a job as an attorney in the genteel south, she was recruited to be the first female attorney to work in the Department of Justice in Washington, D.C. She retired after 40 years with the department, having worked for 16 U.S. attorneys general, with such notables as Robert Kennedy and Elliot Richardson. Little did she know then that her most passionate work was about to begin.

After moving to San Diego in the early 1970s, her husband, Bill, who was from San Diego and active in the community, suggested she get involved. She told him that she had come out West to get away from the hustle and bustle of Washington, D.C. That soon changed, and her involvement with Scripps Memorial Hospital La Jolla has continued to flourish ever since.

As a member of the hospital's community advisory board, Bill had been the deciding voter to move the original Scripps Memorial Hospital in downtown La Jolla to its present location in the early 1960s, inspiring Pat to take on worthwhile projects. After being instrumental in researching eye centers in major U.S. cities, she and Bill helped established what is now the Scripps Mericos Eye Institute. She also helped build the Scripps Polster Breast Care Center and create the hospital's community advisory board, just to name a few noteworthy accomplishments. More than 30 years later, she is still involved with Scripps La Jolla.

"In all I do here, it's in memory of Bill. His heart was here," says Pat, who will soon celebrate her 100th birthday. "The satisfaction of helping others has been uplifting and I'm thankful for that."

#### Acura Classic Benefit All Aces for Scripps Polster Breast Care Center
