# The Effect of Double-Dose Clopidogrel and Prasugel in Individuals with High On-Treatment Platelet Reactivity and Known, Relevant CYP2C19 Genotype Variants –Results from the PREDICT Pilot Study and the Larger Scripps Clinic Registry

Objectives: To demonstrate the impact of CYP2C19 cytochrome gene variants on platelet reactivity in a real-world registry of individuals on clopidogrel post-coronary intervention at Scripps Clinic in La Jolla, California; to determine whether these cytochrome gene variants are better predictors of high on treatment platelet reactivity (HTPR) than known clinical factors; to determine whether doubling the clopidogrel maintenance dose or substituting prasugel in individuals with high on treatment platelet reactivity HTPR provides incremental and adequate platelet inhibition in patients carrying CYP2C19 gene variants.
